Pheasant Hunting Program Requirements & Rules

Our annual stocked Pheasant hunting program is open to all members at no cost to participate.

The number of weeks the program will run each year, as well as number of birds stocked each week is at the discretion of the Pheasant Chairperson(s).

Requirements to participate:

You must have a valid Connecticut Resident/non-resident Firearms Hunting License or 3 day out-of-state bird hunting license. A resident game bird conservation stamp is not required. You must adhere to all State of Connecticut DEEP and PFG hunting rules and regulations. You must provide proof of your Hunting License.

You must attend all pre-shoot safety briefings prior to hunting.

Rules:

On the day(s) of the shoot, all participants must report to the sign in area by the outdoor rifle range for a safety briefing. All participants shall sign in and have their licenses verified.

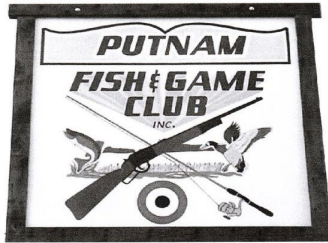
400 square inches of Fluorescent Orange Clothing worn above the waist and visible from all sides must be worn at all times while outside of the staging area.

The Pheasant Chairperson(s) are in charge of the event. You must wait for instructions from them before going into the field to hunt.

For safety, anyone who shows up late after the hunt has started must wait until all hunters have returned from the field. If time allows, they may receive a safety briefing and will then be instructed by the Pheasant Chair's to proceed into the field to hunt.

The Pheasant hunting program is for shotgun only from .410 Gauge up to 12 gauge. Unplugged shotguns are allowed.

Shot size larger than #8 up to #5 is **ONLY** allowed in the pheasant field when hunting in the direction away from Stonebridge road (see Fig 1.). Otherwise #8 and smaller may be used on the rest of club property. All legal shot size restrictions apply. Lead shot only.

The daily bag limit is 2 – birds,

Please be aware of your target and what is beyond, to avoid any accidents or unnecessary damage to building or property.

Please do not walk your dog on the property during the pheasant shoots if you are not hunting to avoid spooking the birds. We want to retain as many birds as possible for the hunters.

If you are approached by any Executive Committee member, RSO or the Range Chairman, you are required to provide proof of current hunting licensing and current membership if requested.

Hunting pheasant during week days is only allowed while the pheasant hunting program is underway.

The outdoor ranges will remain open during the week. Please keep a safe distance from the ranges and buildings for safety.

The Fluorescent Orange requirement applies at all times while hunting pheasant on property

Anyone in violation of PFG or State of Connecticut DEEP rules and regulations will have his/her hunting and membership privileges immediately suspended, and may be reinstated pending a review by the executive committee.
